Mayor Paul Herold called the meeting to order at 6:30 p.m.

On behalf of the Fort Atkinson Historic Commission, Myles Kupka reported the 2014 annual report has been submitted to the State Historical Society. Kupka noted that his and Alan Becker's terms have ended but both agreed to a re-appointment. Kupka also pointed out there are members of the Commission who have served for numerous years and encourage the Council to begin looking for other city residents to replace them.

Sarah Snitker from Upper Explorerland Regional Planning Commission (UERPC) explained various housing programs their organization has available to assist individuals who meet the qualifications. There are programs that can offer assistance to qualifying home owners for things such as furnaces, windows, doors, roofing, etc as well as rental assistance to those who may be eligible.

The Mayor and Council discussed street sweeper needs and looked over specifications of several used street sweepers. The Council authorized Greg Barta to go on location to check them out.

Motion by Elsbernd to approve the following consent items: January 7, 2015 council minutes, clerk's reports, and monthly bills, seconded by Schmitt, carried.

There was nothing to report on the sewage lift station project.

There was a general discussion regarding the FY2016 Budget. The proposed tax levy for the FY2016 Budget is \$12.67. An increase of \$.23 from the current levy of \$12.44. The Mayor and Council discussed the many needs within the City and along with routine expenditures are proposing to purchase a different street sweeper, concrete repairs by the gym and library, increase Mayor and Council pay, paint water hydrants and proceed with replacing the sewage lift station. Wages for the city clerk and were also discussed.

Glass made a motion authorizing an increase of \$.75/hr. beginning FY2016 for both the city clerk and city water/sewer/street superintendent, seconded by Elsbernd, carried.

Due to a conflict, the March 2015 regular council meeting will be re-scheduled to Tuesday March 3rd instead of Wednesday March 4th.

Elsbernd made a motion setting the public hearing date and time for the FY2016 budget for March 3, 2015 at 6:30 p.m., seconded by Karnik, carried.

Schmitt noted the St. John's church guild will be giving the community center facility a deep cleaning later this month.

Schneiter made a motion to adjourn, seconded by Karnik, carried. Meeting adjourned at 8:05 p.m.
