

Present: Glass, Schneiter, Karnik, Schmitt, Elsbernd.

Mayor Paul Herold called the meeting to order at 7:30 p.m.

Myles Kupka, representing the Fort Atkinson Historic Preservation Commission, told the Mayor and Council Alan Becker and Marie Riha's terms on the Commission expired 12/31/2012. He noted both would like to continue to serve and recommended the Council reappoint them. Kupka also expressed the need to find more individuals interested in serving on both the Museum Committee and Historic Preservation Commission.

Elsbernd made a motion to re-appoint Alan Becker to a two year term; 1/1/13-12/31/14 and Marie Riha to a three year term; 1/13/13-12/31/15 to serve as members of the Fort Atkinson Historic Preservation Commission, seconded by Schmitt, carried.

Ron Franzen reported the fire department is planning to apply for a Community Foundation Grant to help fund thermal imaging camera equipment.

Greg Barta reported work was routine for this time of year and he continues to work with the city's engineer on the sewer lift station improvements.

Motion by Schneiter to approve the following consent items: December 5, 2012 council minutes, clerk's reports, and monthly bills, seconded by Glass, carried.

Schneiter made a motion introducing **Resolution #244**, a resolution establishing anchoring requirements for fuel tanks located in the City of Fort Atkinson's Flood Plain, seconded by Karnik.

The Mayor put the question on the motion and the following named Council members voted:

Ayes: Glass, Schneiter, Karnik, Schmitt, Elsbernd.

Nays: None.

Whereupon the Mayor declared said motion carried and the resolution approved.

Schmitt prepared a narrative profiling the City for area travel and tourism guides and presented it to the Mayor and Council for their input. Schmitt was commended for her efforts. The narrative will be submitted to area tourism guides.

The Mayor and Council reviewed preliminary budget figures for the FY2014 Budget. There was a general discussion with plans to further discuss the matter at the February 6th council meeting.

Schneiter made a motion to adjourn, seconded by Glass, carried. Meeting adjourned at 8:20 p.m.
