Mayor Herold called the meeting to order at 7:30 p.m.

Mayor Herold announced the public hearing concerning the FY10 Budget Amendment was open for comments. There were no oral or written comments made. Mayor Herold then declared the public hearing closed.

The Mayor gave members of the audience an opportunity to speak if they had something new to add regarding the naming of the baseball field and park. Comments were made on the issue.

Barta reported the heater in the community center's dishwasher needs to be replaced. Barta also presented estimates to the Council to install soffit and trim on the library building and railings for the ball park. The Council told Barta to go with the low bids.

Myles Kupka approached the Council asking if signs could be installed marking the location to the City's Oak Hill Cemetery. The City will take care of doing so.

Ron Franzen reported updates to the City's fire station; new ceiling tiles, lighting and door openers, was almost complete. Franzen also said work on the military generator continues as they try to discover what its output is. Franzen noted there are plans being made for a community Rendezvous meeting scheduled for Sunday May 16th at the Community Center. Campfire Music is the chosen theme for the 2010 Rendezvous.

Glass made a motion to approve the following consent items; April 7, 2010 council minutes, clerk's reports, and the monthly bills, seconded by Bulgren, carried.

Mayor Herold asked the Council if there was more discussion on naming the baseball field and park. Schmitt expressed to the Council some things to be taken into consideration when making their decision

Bulgren made a motion introducing **Resolution #230**, a resolution recognizing and naming the newly constructed ball field and camping park the "Fort Atkinson Community Park", seconded by Glass.

The Mayor put the question on the motion and the following named council members voted:

Ayes: Bulgren, Glass, Schneider.

Nays: Schmitt, Elsbernd.

Whereupon the Mayor declared said motion carried and the resolution approved.

Elsbernd made a motion introducing **Resolution #229**, a resolution amending the current budget for the fiscal year ending June 30, 2010, seconded by Schneider

The Mayor put the question on the motion and the following named council members voted:

Ayes: Bulgren, Glass, Schmitt, Schneider, Elsbernd.

Nays: None.

Whereupon the Mayor declared said motion carried and the resolution approved.

Glass made a motion approving building permit applications submitted by Zetta Heckmann, Dale Leuenberger and Jerry Krivachek with a stipulation on Krivachek's building permit requiring the structure be placed on a concrete foundation in sixty days, seconded by Bulgren, carried.

Schmitt made a motion approving Mayor Herold's recommendation to appoint Lisa Schroeder, Denise Elsbernd, and Joyce Barta to the Fort Atkinson Library Board to replace the three board members whose term expire June 30, 2010, seconded by Schneider, carried.

Glass reported a cracking problem with the sidewalk in front of Rebecca's Beauty Salon.

Mayor Herold told the Council FEMA is reviewing and making new flood maps. It is hopeful that within a year the project will be completed. The City will have until 2012 to become compliant and become a member of the National Flood Insurance Program.

Schneiter made a motion to adjourn, seconded by Glass, carried. Meeting adjourned at 8:10 p.m.
