

Present: Glass, Schneiter, Elsbernd, Karnik, Schmitt.

Marissa Goerend was present during the meeting for Careers Class. Max Krivachek was also present.

Mayor Paul Herold called the meeting to order at 7:30 p.m.

Sarah Schmitt and Theresa Barta asked if an adult Bible study group could use the Library's basement meeting room for their meetings. The group's members would like to meet on the first and third Monday of each month. The Council gave the group the go ahead to use the Library meeting room for their meetings. S. Schmitt and T. Barta also explained a Christian youth group is forming for 6th, 7th & 8th graders. The group would like to use the gym or community center to host their monthly meeting and occasional social event. Council gave their approval to the youth group to use the gym or community center but they must make sure to schedule a head of time to avoid conflicts.

Greg Barta reported: hydrants have been flushed, selected sewer lines have been cleaned and televised, two hidden curb stops were located, and maintenance to the dike is almost complete. Barta noted he is getting cost estimates for the work needed to be done to the storm sewer intake and sidewalk at the intersection of Hwy 24 and 5th St.

Motion by Schneiter to approve the following consent items: September 5, 2012 council minutes, clerk's reports, and monthly bills, seconded by Glass, carried.

The Mayor and Council had a general discussion with Barta concerning the information submitted by the city's engineer for upgrading the lift station. Barta will do more research on the options available. Preliminary cost estimates put the project in excess of \$100,000.

The Mayor and Council briefly discussed problems that can arise during flooding with LP tanks that are not properly anchored down. The City's flood plain ordinance requires tanks to be anchored but it does not specify any requirements as to how they should be anchored. The city clerk was directed to prepare a resolution establishing a policy containing requirements and guidelines for anchoring LP tanks.

Topics for general discussion included hanging planters, fluoride, and Rendezvous.

Glass made a motion to adjourn, seconded by Schneiter, carried. Meeting adjourned at 8:40 p.m.
