Mayor Paul Herold called the meeting to order at 6:30 p.m.

David Shatek reviewed two options proposed for building a garage at 110 4th Street NW with the Council. After a discussion, Elsbernd made a motion approving a building permit for Matthew & David Shatek using the option two plan for the project, seconded by Schneider, carried.

Schneider made a motion approving Contract Payment #1 for the Influent Lift Station Modification Project to Blazek Corporation in the amount of \$12,920.00, seconded by Karnik, carried.

Tom Madden updated the Mayor and Council on the sewage lift station project. Madden also gave an update on the progress being made on the wastewater treatment facility project explaining the Wastewater Treatment Facility Plan, the Anti-degradation Alternative Analysis and the Intended Use Plan has been filed with the DNR. The next step is to complete the CDBG application which is due January 8, 2016.

Greg Barta discussed with the Mayor and Council what will need to be done with the landscaping around the new lift station.

Motion by Glass to approve the following consent items: August 5, 2015 council minutes, clerk's reports, and monthly bills, seconded by Schmitt, carried.

The Council reviewed the options submitted by Alliant Energy for an electrical service to the new lift station. Schneider made a motion approving Alliant Energy's option 5 electrical service going from the existing transformer pole to the new sewer lift station, seconded by Glass, carried.

Elsbernd made a motion approving a Municipal Advisory Service Agreement between the City of Fort Atkinson and Northland Securities, Inc. seconded by Schmitt, Carried.

Glass made a motion approving a "Back-to-Work Policy" for city employees, seconded by Karnik, carried.

Sidewalk permits submitted by Raymond Lensing, Earl Lensing and Home Front Properties were reviewed and accepted by the Council. It was the consensus of the Council there would be no charge for sidewalk permits unless new sidewalk was being installed where none previously existed or there is a design change in a sidewalk already existing.

Glass made a motion approving a building permit for Jake Bruess, seconded by Schneider, carried.

Glass made a motion to adjourn, seconded by Schneider, carried. Meeting adjourned at 7:30 p.m.
